# What's Happening: Delivery

- Delivery from LLNJ through June 2019 as per LLNJ contract with NJSL
- Network regulations specify that NJSL provides delivery
- LLNJ has renewed delivery contract through 12/31/19

# What's Happening: Delivery

- Cost share
  - Membership approved June 13, 2018
  - Plan approved by LLNJ Board
  - Sliding scale based on number of stops per week
  - Estimated bill sent out in September
  - Commitment to pay in 2019 due Nov. 8th

# Impact of BCCLS Decision

- BCCLS starting own delivery by 6/30/19
- Will still participate in Statewide  
Delivery through BCCLS office depot
- No cost savings for LLNJ during FY19
