# Taskforce On Post COVID-19 Alignment, Trends and Strategies

Status Report - May 2020

Since the LibraryLinkNJ Executive Board established TOPCATS on April 16 to explore issues, strategies, and solutions, relative to the reopening of libraries post COVID-19, the Task Force has invited library colleagues from all multi-type libraries and various organizations and from throughout the State. We will continue to reinforce inclusiveness and representation of library staff of all levels for more effective approaches in carrying out our charges, in collaboration with the <a href="New Jersey State Library">New Jersey Library Association</a> (NJLA), and other pertinent efforts that benefit New Jersey libraries in the post COVID-19 environment.

The Task Force has been working diligently to plan, implement, and deliver practical outcomes in the following Areas of Inquiry:

- 1. Coordinated efforts for reopening New Jersey's libraries
- 2. Needs assessment for providing library services post COVID-19
- 3. Communication Strategies for reopening our libraries
- 4. Staff training for working in a post COVID-19 environment
- 5. Advocacy for the inclusion of libraries in New Jersey's reopening initiatives
- 6. Framework for New Jersey libraries' response, recovery, and resilience in the post COVID-19 environment

We expect this survey results to help TOPCATS in revising documents we've developed and planning for future activities.

In response to the Governor's <u>Executive Order 142</u>, Policy & Advocacy WG sent a letter to the Governor's Restart and Recovery Advisory Council for clarification on whether this applies to libraries. Juliet & Chris reached out to one of the Governor's aides, and we also reached out to the State Library on this matter. It is possible that another Executive Order may be issued that may mention libraries by name.

In the meantime, Policy & Advocacy WG reached out to Best Practices WG to review EO 142, and Best Practices WG developed this Best Practices document for curb-side service that libraries will apply to adapt to their needs, as we need to encourage libraries to begin now to plan for providing curbside services.

### Improving Accessibility to Technologies in New Jersey Community

Futures WG has acknowledged and been looking at the issue of technology and digital divide in NJ communities. The WG is currently working on a statement about the digital divide and digital equity that they hope to release soon. They are also exploring various short-term and long-term solutions, including broadband connectivity and hot spot lending, which may require close collaboration with the State Library. TOPCATS will also discuss a possibility to get funds through the CARES Act. This may be a good way to do a partnership between libraries and schools.
